The vehicle is not subject to any encumbrances or charges, unless stated in this document on page 4, in which case I/We authorise You to settle the sale of the Vehicle and repay to the lender any sum outstanding on the Vehicle in order to obtain a release of any charge registered on the Personal Property Security register or other security.
5. The Vehicle has not travelled any more distance than is registered on the odometer.
6. The Vehicle is registered in my/our name, or \_\_\_\_\_ (Proof of ownership provided with driver licence of owner if not being sold by registered owner)
7. To the best of our knowledge the Vehicle has not sustained accident damage other than the damage listed on page 2. That the Vehicle is comprehensively insured until sold, such insurance to include cover for you as a motor vehicle dealer while the vehicle is in your care and control (or your agents) and shall include cover for damage caused by the negligence or breach of duty as a bailee of you or your agents.
